



BYLAWS

Proposed amendments to:

ARTICLE VI

BOARD OF DIRECTORS

AUTHORITY - Subject to directives of annual and special meetings and these Bylaws, the Board of Directors shall have authority over the activities and assets of the Association.

COMPOSITION - One representative from each home owners association (8) to be determined by those associations; if a candidate is not presented by a home owners association then an at large representative may be elected., One additional and four at large representatives to be elected at the annual meeting. From these 12 <u>9</u> representatives they will choose among themselves, who will fill serve in the following positions:

One President.

One Vice-President.

One Secretary.

One Treasurer.

ELECTION - The Board of Directors shall nominate one or more members for each vacant position on the Board. Additional nominations of members, present at the annual meeting and willing to serve, shall be taken from the floor. All elections for the Board shall be conducted by secret, written ballot.

TERMS OF OFFICE - Directors are elected for twothree-year terms. Their terms shall expire after the annual meeting or upon the election of new Directors, whichever occurs later. The terms of office of President, Vice-President, and two at-large directors expire in even-numbered years. The terms of office of Secretary, Treasurer, and two at-large directors expire in odd-numbered years. Therefore three offices expire each year.

BOARD MEETINGS - The new Board shall meet within 60 days of the annual meeting and at least three other times prior to the next annual meeting. Regular meetings shall be held at places, dates, and times established by the Board. Special meetings may be held on the call of the President or any three Directors after at least 24 hours notice by telephone, fax, mail, electronic communication or personal contact. Five <u>Four</u> directors shall constitute a quorum for the transaction of business. The meetings shall be open to the members. Decisions shall be made by majority vote of directors present, with the President voting only to break ties. Between meetings, the President may solicit decisions from the Board through written communications as provide by Minnesota 317A.239.


